ALLIED MILITARY GOVERNMENT IN GERMANY-

Mr. GRAYDON:

1. How many Canadian citizens are there in Germany connected with the work of the allied military government in that country?

2. What relation does this number bear to the number of citizens of the United Kingdom and citizens of the United States of America, respectively, who are engaged in Germany on work connected with the allied military government?

Mr. MACKENZIE KING:

1. Under the terms of the declaration regarding the defeat of Germany, signed in Berlin on the 5th June, 1945, supreme authority with respect to Germany was assumed by the governments of the United Kingdom, the United States of America, and the Union of Soviet Socialist Republics, and the provisional government of the French republic. The Canadian government does not participate in the administration of the allied military government, which is supervised by these four powers. For this reason statistics regarding personnel employed in Germany in the work of the allied control authority are not normally communicated to this government. A number of Canadian citizens have, however, offered their services to, and have been employed by the allied control authority (British element) in Germany. Precise figures as to the number
