VANCOUVER-CONSTRUCTION OF SASKATCHE-WAN WHEAT POOL ELEVATOR

On the orders of the day:

Hon, Alvin Hamilton (Qu'Appelle): Mr. Speaker, I would direct my question to the Minister of Finance in his capacity as minister reporting for the Canadian Wheat Board. In view of the long struggle that we had to persuade the Saskatchewan wheat pool to build an elevator at Vancouver, would the minister consider getting in touch with officials of this grain organization to see whether they would not reconsider the stopping of work on the five million bushel terminal at Vancouver which I understand has been precipitated by the cancelling of the government contract for the elevator at Prince Rupert.

Hon. Mitchell Sharp (Minister of Finance): Mr. Speaker, the president of the Saskatchewan wheat pool was in touch with me several days ago. Subsequently I had a letter from the secretary of that organization, and I agreed to see the president as soon as he could come to Ottawa for discussions. The president of the Saskatchewan wheat pool informed me, at the time of the first telephone call, that they had just received bids for the new terminal at Vancouver and that they were 30 per cent above their expectations. For this reason in particular they were reconsidering whether they should proceed,
