Hon. E. J. Benson (Minister of National Revenue and President of the Treasury Board): Mr. Speaker, I shall be speaking in the budget debate on the matter of expenditures of the federal government. I should like to point out that practically all the major recommendations of the Glassco commission have been put into effect by this government.

Mr. Baldwin: Mr. Speaker, I will not be argumentative. I simply ask the hon. gentleman whether he will arrange to accelerate the implementation of those recommendations which would make more credible the efforts of the Minister of Finance in his dealings with industry and labour.

Mr. Benson: I should simply like to say that the government and the civil service have been moving as fast as is humanly possible in the implementation of the recommendations of the Glassco commission. I believe that if someone were to ask Mr. Glassco, his reply would be that he is astonished to find how much has been done.
