**Hon. Jean Marchand (Minister of Regional Economic Expansion):** Mr. Speaker, I have followed fairly closely what has happened in the Atlantic provinces. It is true that the department has been criticized, with reason, I believe, in some cases. We shall remedy what is wrong.

Obviously, the hon. member has forgotten part of it, because even the chairman of APEC has stated that he supported the department and that, on the whole, he was satisfied, even if there were deficiencies.

At any rate, the report that was published includes some very serious errors, and we are considering all that. We shall, no doubt, correct what needs to be corrected. But to claim that, as a whole, the programs of the department have been inefficient is to make an altogether gratuitous statement based on prejudices.

**Mr. Douglas:** In view of the fact that the chairman and others indicated that their main criticism was levelled at the fact that the programs were ad hoc and were lacking in long-term planning and co-ordination, does the minister intend to make a statement to the House regarding any long-term targets which his department is establishing and, if so, when may we expect such a statement?

#### ATLANTIC PROVINCES—REQUEST FOR INDICATION OF DEPARTMENTAL GOALS AND STRATEGY

**Mr. David MacDonald (Egmont):** In view of the fact that not only the recent APEC report but an earlier and much more direct report of the minister's own agency, the Atlantic Development Council, suggested a strategy and some specific goals with regard to the development and economic improvement of the Atlantic region, and as the latter report has been on the minister's desk for some months, I wonder when the minister will be in a position to indicate to the House and to the people in the Atlantic provinces what particular goals and strategy will be acceptable to his department and to the government?

**Hon. Jean Marchand (Minister of Regional Economic Expansion):** Mr. Speaker, we have already accepted several recommendations made by the Atlantic Council, among others the establishment of a management institute as well as a labour institute. We have accepted several others, but it would take too long to list them. Some appear to us to be unacceptable and unrealistic. The APEC report contains gross errors. For example, it is mentioned that there is an extensive centralization in the department—

#### RENEGOTIATION OF PRINCE EDWARD ISLAND DEVELOPMENT PLAN
