Canada that favours one airline over another. Indeed, Open House Canada tries to achieve maximum effectiveness of both airlines.

There has been some problem during the course of the summer in respect of the central travel service of Air Canada, which I think is what led the member to believe there was some direct bias in favour of the direct travel service of Canadian Pacific. Just so the record can be clear, the member indicated some figures on Tuesday which would indicate a rather disproportionate share of the business being directed toward Canadian Pacific. The fact is that Canadian Pacific is not the only or the biggest carrier of Open House Canada participants. On a national basis I would have to report that in fact the groups using Air Canada do significantly outnumber those using Canadian Pacific. The hon. member referred specifically to five western cities, I think, where Canadian Pacific had been, indeed, more active, but on a total basis actually Air Canada has been more active in respect of the travel program of Open House Canada participants than anyone else.

I think that statement was needed just so there will be no thought that I had, even inadvertently, misled the member or the House.
