## ANTI-BALLISTIC MISSILE TREATY

Mr. Derek Blackburn (Brant): Mr. Speaker, my question is also directed to the Prime Minister and relates to the meeting held in Reykjavik on the weekend. How does the Government intend to support the ABM Treaty now that President Reagan has made clear his intention to test and deploy ABM systems outside the laboratory within 10 years?

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, I would not want to try to anticipate what may or may not happen in the next 10 years but our treaty is clear and the position of the Government of Canada with regard to ABM is clear. We have conveyed that to all Parties. There has been no change in our position.

#### POSITION OF UNITED STATES SECRETARY OF STATE

Mr. Derek Blackburn (Brant): Mr. Speaker, it is now clear from the weekend conference that the United States intends to violate the ABM Treaty. Exactly a year ago, Secretary of State Shultz stated at the North Atlantic Assembly meeting in San Francisco that the United States would adhere to a strict or restrictive interpretation of ABM. Would the Prime Minister not agree now that George Shultz lied to us a year ago?

Mr. Speaker: Order. I wonder if the Hon. Member would like to rephrase his question.

Mr. Blackburn (Brant): I will put it in the way we would say it in our own Chamber. Would the Prime Minister not agree that the Secretary of State for the United States misled the North Atlantic Assembly so that we would pass a pro-SDI resolution at that very important meeting of parliamentarians of NATO countries?

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, I do not think that George Shultz needs me to defend his honour. It is well known and well accepted both here and around the world.

FORGET COMMISSION'S FORTHCOMING RECOMMENDATIONS

Hon. Warren Allmand (Notre-Dame-de-Grâce—Lachine East): Mr. Speaker, my question is for the Prime Minister. ## BENEFITS PAID TO FISHERMEN
