## HOUSING

Hon. Alan Redway (Don Valley East): Mr. Speaker, my question is for the Minister of Finance. In yesterday's Speech from the Throne the government set a target of creating some 2.5 million new jobs. The minister is well aware that one of the main reasons for double digit unemployment in this country at the present time is the slack construction industry.

Will the minister agree to create housing construction jobs by stimulating demand without increasing the debt or the deficit through the introduction of a 5 per cent down payment for first-time home buyers?

I also know that he will be encouraged by the fact that interest rates have receded by five percentage points in the last 11 months or so. That is all good news. There has been improved confidence expressed by the business community, and I think that is welcome news as well.

That is the best way to stimulate the housing industry. I am pleased to note as well that at yesterday's annual conference of home builders, they indicated they felt things were turning around and getting better.

With respect to the point the hon. member raised about the 95 per cent mortgages, we are examining that very carefully and will report back to the hon. member in due course.
