REGISTRATION OF LOBBYISTS

COMPREHENSIVE REVIEW OF ACT

Mr. Jim Edwards (Parliamentary Secretary to Minister of State and Leader of the Government in the House of Commons): Mr. Speaker, I rise to seek unanimous consent for the following motion:

That pursuant to section 14 of an act respecting the registration of lobbyists, chapter 44, 4th supplement, Revised Statutes of Canada 1985, the Standing Committee on Consumer and Corporate Affairs and Government Operations be the committee to undertake a comprehensive review of the administration and operation of this act and submit a report to the House no later than one year after the review is undertaken.

PETITIONS

BILL C-330

Mr. Stan Keyes (Hamilton West): Mr. Speaker, I have the honour and duty to present to the House petitions certified correct by the clerk of petitions that contain the signatures of yet another 10,000 Canadians who support Bill C-330.

The petitioners want Canadians to have a greater say in the disposition of offenders in the judicial process and

call upon Parliament to support victims' rights and the protection of the public from violent offenders.

There will be tens of thousands of signatures to present to this House before Bill C-330 is presented this Thursday.

YOUNG OFFENDERS ACT

Mrs. Diane Marleau (Sudbury): Mr. Speaker, I have the honour of presenting before this House petitions that were circulated as a result of the death of young Rosalynn Dupuis in the Regional Municipality of Sudbury. A young offender has been charged with her death.

The people who have signed these petitions—there are many indeed—ask that the government bring forth changes to the Young Offenders Act in order that those who commit violent crimes be sentenced in a way that would represent the severity of their crimes. The petitioners ask that violent young offenders be psychologically assessed and that psychiatric treatment of these young offenders who have committed murder be mandatory and immediate upon sentencing.

REQUEST FOR ELIMINATION OF VIOLENCE IN OUR SOCIETY

Mr. Guy Saint-Julien (Abitibi): Mr. Speaker, I am tabling a petition from Charles-René-Lalande School in Rivière-Héva, Abitibi. The petitioners say that violent movies on television are dangerous and therefore unacceptable because they incite more violence and that all toys that incite violent games are unacceptable and should not be made.

Information on violent acts that is repeated too often on all television stations and on radio can lead to other acts of violence.

Therefore the petitioners humbly ask Parliament to legislate on the above-mentioned points to eliminate violence in our society and thus better protect our children and give all our fellow citizens a better quality of life.
