news I have received is true, that the French announcers have been instructed to pronounce that word as well as do the English-speaking announcers. I hope that tomorrow the honourable Leader of the Government will be in a position to tell us. If it is true, it will mean a reform and a change in the pronunciation of one word. Honourable senators may say that it is a very small thing, but it is important because it is a reform. It is a lesson to those "know-alls."

CAPITAL PUNISHMENT

COMMUTATION OF SENTENCES—INQUIRY
ANSWERED

Hon. Mr. Pouliot inquired of the Government, pursuant to notice:

In the course of the past ten years, how many sentences for capital punishment have been commuted in the case of persons found guilty of (a) murder, (b) rape and murder, and on what date has each of these commutations been decided?

Hon. John J. Connolly: The answer to the honourable senator's inquiry is as follows:

There are no cases of persons having been found guilty of rape and murder. Section 499 of the Criminal Code provides that:

"No count that charges an offence other than murder shall be joined in an indictment to a count that charges murder."

Section 856 of the old Criminal Code was to the same effect.

In the course of the past ten years the number of persons whose sentences for capital punishment have been commuted to life imprisonment is as follows:

Hon. Mr. Pouliot: Honourable senators, with respect to the answer that has been given as to clemency in matters of murder and rape, I will say that the so-called experts of the Department of Justice have tried to split hairs. They often do that. One part of their answer is futile. The other gives the number of commutations of death sentences, which is so formidable for the last nine years that it is really shocking. Let us hope that the Government will be very careful about its policy in regard to clemency for sex perverts convicted of offences such as rape and murder.
