## INLAND REVENUE RETURNS

Show that the consumption of Spirits in Ontario per head of population has decreased within the past 20 years fully one third, and tobacco has increased in the same period fully one-half. The consumption of beer has also increased considerably, nearly 1/2 th since 1875.

The consumption of beer has also increased considerably, nearly 1/4th since 1875.

For the Dominion the consumption per head in round figures is: 11/4 Galls. Spirits; 21/2 Galls. Beer; Petroleum the same as Spirits and Tobacco 2 lbs. The selfish and filthy habit of tobacco using might also very fitly enter the denunciatory category of temperance enthusiasts.

An average of the past 2 or 3 years show that 25,000,000 lbs. grain was used, 1,400,000 galls. of proof spirits made and \$1,400,000 duty paid each year at Walker's Distillery, Walkerville.

## "CONSUMMATIONS DEVOUTLY TO BE WISHED."

County Councils of 5 members elected directly by the people.

Township School Boards of 5 members elected directly by the people.

Statute Labor payable in labor abolished, and its substitution by cash payments.

Road Masters abolished and the appointment of one capable township Road Commissioner,
