THE MAN WHO DROVE HIS LICENSE

Is Charged, in Montreal Court for Practising Without One.

CURED WHERE WHITE DOCTOR'S FAILED. Father and Grandfather were Medicine Men—Fine of Ten Dollars and Costs Imposed by Judge.

Montreal, Jan. 12.—Slowly civilization has pushed the noble red man farther and farther back and he has lost many of his most picturesque habits, some of them fallen in disuse.

Today in the police court a case came up which was probably unique in the annals of the court. A Casagwawa Indian medicine man by the name of Dominick Twoaxe was brought before the court charged with practicing medicine without a license.

The action was taken by the College of Physicians and Surgeons of the province of Quebec, which is the governing body of the medical profession in this province.

Mrs. R. Montour, a Casagwawa Indian, had been suffering from an illness for many years, and she had been treated by the white man's doctors without avail, and finally turned to one of her own race, Dominick Twoaxe, the accused.

Under examination Twoaxe stated that his father and grandfather had been Indian medicine men and that they had always been practicing the medicine of one tribe of the Iroquois. He stated that he had been compounding and selling his medicine for the past ten years.

SYNOPSIS OF CANADIAN NORTH-WEST MINING REGULATIONS.

COAL.—Coal mining rights may be leased for twenty-one years, renewable at an annual rental of \$1 an acre. Not more than 250 acres can be leased to one applicant. Royalty, five cents per ton. In unreserved territory the tract may be staked out by the applicant in person, and personal application to the Agent or sub-Agent of Dominion Lands must be made within thirty days after filing application.

SYNOPSIS OF CANADIAN NORTH-WEST LAND REGULATIONS.

THE sole head of a family, or any male over 18 years old, may homestead a quarter section of available Dominion land in Manitoba, Saskatchewan or Alberta. The applicant must appear in person at the local office of the Sub-Agent for the District. Entry by proxy may be made at the office of any local Agent of Dominion Lands (not sub-agent) on certain conditions.
