

Resolved, That this House do immediately resolve itself into the said Committee.

The House accordingly resolved itself into the said Committee, and, after some time spent therein, Mr. Speaker resumed the Chair; and Mr. Brodeur reported, That the Committee had gone through the Bill, and directed him to report the same without any amendment.

Ordered, That the Bill be now read the third time.

The Bill was accordingly read the third time.

Resolved, That the Bill do pass.

Ordered, That the Clerk do carry the Bill to the Senate, and desire their concurrence.

Mr. Brodeur reported from the Committee of Supply, several Resolutions; which were read, as follow:—

1. Resolved, That a sum not exceeding One thousand one hundred and ten dollars and eighty-three cents be granted to Her Majesty, for Department of Justice—Further amount required for contingencies, \$1,000; To pay A. J. McGillivray for one month's salary (notwithstanding anything to the contrary in the Civil Service Act), \$60; To pay F. Perchard, sr., for one month's salary (notwithstanding anything to the contrary in the Civil Service Act), \$33.33; To pay F. Perchard, jr., for one month's salary (notwithstanding anything to the contrary in the Civil Service Act), \$17.50, for the year ending 30th June, 1897.

2. Resolved, That a sum not exceeding Three thousand five hundred dollars be granted to Her Majesty, for Administration of Justice—Salary of an additional County Judge in Manitoba, \$2,000; Additional amount required for circuit allowance, British Columbia, \$1,000; Supreme Court of Canada, further amount required for contingencies, \$500, for the year ending 30th June, 1897.

3. Resolved, That a sum not exceeding Five hundred and thirty-nine dollars and ninety cents be granted to Her Majesty, for Dominion Police—To pay a gratuity of two months' salary to the widow of the late Constable Stringer, \$100.65; To provide for a retiring allowance to Constable Prudhomme, \$439.25, for the year ending 30th June, 1897.

4. Resolved, That a sum not exceeding One hundred dollars be granted to Her Majesty, for Civil Government—Department of Customs—To pay for services of T. Graham, as extra clerk, from 1st July to 30th September, 1896, at the rate of \$400 per annum (notwithstanding anything to the contrary in the Civil Service Act), for the year ending 30th June, 1897.

5. Resolved, That a sum not exceeding Seven hundred dollars be granted to Her Majesty, for Department of Trade and Commerce—To provide salary of one 3rd class clerk, omitted in the main estimates, for the year ending 30th June, 1897.

6. Resolved, That a sum not exceeding One thousand one hundred dollars be granted to Her Majesty, for Department of Inland Revenue—To provide for the salary of one 2nd class clerk, omitted from main estimates, for the year ending 30th June, 1897.

7. Resolved, That a sum not exceeding Two hundred dollars be granted to Her Majesty, for Department of the Geological Survey—Additional amount required to provide for the salary of messenger, entered in the main estimates through error as \$300, should have been \$500, for the year ending 30th June, 1897.

8. Resolved, That a sum not exceeding Six hundred and thirty-seven dollars and ninety-eight cents be granted to Her Majesty, for Department of the Secretary of State—To pay A. E. Blount, for clerical assistance to the late Secretary of State (notwithstanding anything to the contrary in the Civil Service Act), \$256.66; Further amount required for:—Stationery, over-expended in 1895-96, \$241.32; Sundries, over-expended in 1895-96, \$140—\$381.32, for the year ending 30th June, 1897.

9. Resolved, That a sum not exceeding One thousand nine hundred dollars be granted to Her Majesty, for Department of Public Works—To pay arrears of subscriptions to newspapers, reviews and other publications, 1889-96, \$1,450; To provide for one 3rd class clerk, omitted in main estimates, \$450, for the year ending 30th June, 1897.
