and House of Commons Act (corporate and political office prohibited), which was read the first time and ordered to be printed and ordered for a second reading at the next sitting of the House.

Mr. Friesen, seconded by Mr. McKinnon, by leave of the House, introduced Bill C-401, An Act to amend the Canada Shipping Act (pollution), which was read the first time and ordered to be printed and ordered for a second reading at the next sitting of the House.

Mr. Sharp for Mr. Lalonde, seconded by Mr. Faulkner, by leave of the House, introduced Bill C-68, An Act to amend the Medical Care Act, which was read the first time and ordered to be printed and ordered for a second reading at the next sitting of the House.

Mr. Andras (Port Arthur), seconded by Mr. Sharp, by leave of the House, introduced Bill C-69, An Act to amend the Unemployment Insurance Act, 1971, which was read the first time and ordered to be printed and ordered for a second reading at the next sitting of the House.

The text of the Message and Recommendation of the Governor General pursuant to Standing Order 62(2) in relation to the foregoing Bill is as follows:

His Excellency the Governor General recommends to the House of Commons a measure to amend the Unemployment Insurance Act, 1971 to add, in the manner provided, a new class to the existing classes of insurable employment; to provide, in the manner prescribed, for changes in qualifying periods, benefit periods, entitlement to benefits and, rates of benefits; to provide, in the manner prescribed, for a new basis for the calculation that determines the proportion of the basic cost of benefit for a year that will be borne by the Government; to make the employer's premiums of Her Majesty in right of Canada payable by statute; and to provide for the payment of allowances to persons or their representatives who attend before an umpire on an appeal from a decision of the Minister.

Mr. Munro (Esquimalt-Saanich), seconded by Mr. Neil, by leave of the House, introduced Bill C-402, An Act to amend the criminal law (punishment of certain offences), which was read for the first time and ordered to be printed and ordered for a second reading at the next sitting of the House.

Mr. Reynolds, seconded by Mr. Nowlan, by leave of the House, introduced Bill C-403, An Act to amend the Criminal Code (death sentence), which was read the first time and ordered to be printed and ordered for a second reading at the next sitting of the House. "date 1976: and, with respect to each such gold coin, prescribe that the standard weight shall be one quarter of an ounce Troy weight of gold, the millesimal fineness shall be 916, and the remedy allowance and the least current weight shall be such as are appropriate to that standard weight."
