Hon. Eric W. Kierans (Minister of Com-Between February and March we actually reduced the number of hours of casuals by 110,000, and that is almost 22 per cent or 23 per cent, and the dollar figure reduction was from \$916,000 to \$710,000. We are quite concerned about the problem.

At this moment in Ottawa the unions are meeting with my officers to discuss the whole problem of casuals right across the country. We have issued instructions to the regional offices that the unions and the administration should get together to discuss the problem.

Mr. Rose: Can the minister tell the house what proportion of these casuals have been taken on as permanent employees of the postal service?

Mr. Kierans: I could give the exact figures, but the hon. member will recall we had 2,000 surplus positions to fill and I would not judge that very many of the casuals have been hired permanently. We had to find jobs for the 2,084 who were rendered surplus because of the five day week.

SERVICE AVAILABLE ON SATURDAYS

Mr. A. D. Hales (Wellington): Mr. Speaker, I have a supplementary question for the Postmaster General. Some time ago the minister said that he would give consideration to keeping open on Saturdays all wickets in the lobbies of post offices, rather than just a few sections. Has he anything further to say in this regard?

Hon. Eric W. Kierans (Minister of Communications): We have not reached a decision on that. It does present a problem. We are giving half service, which is not satisfactory at all. We are considering it.

IMPLEMENTATION OF RECOMMENDATIONS IN STAMP DESIGN REPORT

Mr. Heath Macquarrie (Hillsborough): Mr. Speaker, I should like to direct a question to the Postmaster General. It is in reference to the crisp and critical report of the Cunningham task force on stamp design which although tabled today was submitted to the minister in February. Can he advise whether any action is contemplated to implement any of the recommendations for improving what was found to be a pretty unsatisfactory situation.

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, I have not yet received a final answer from the Quebec government; however, yesterday, I was in the Gaspé, and several citizens of the Forillon peninsula offered to give us their lands for the development of a national park.
