If the hon. member has in mind certain persons about whom he has information, it is his duty, in my opinion, to get in touch with the police. But if he is simply thinking of people who are travelling for various reasons, I would of course point out to him that we cannot keep watch on them all.

Mr. Caouette: Mr. Speaker, I do not wish to Following yesterday's events, does he make a statement but simply to ask a supplementary question.

Is the Prime Minister aware that not so long ago Mr. Pierre Nadeau, of the CBC, met in Palestine with two terrorists who had gone there in order to train for performing selective assassination in Canada?
