## INDIAN AFFAIRS

CONVERSION OF COQUALEETZA HOSPITAL INTO COMMUNITY CENTRE

Mr. André Fortin (Lotbinière): Mr. Speaker, I have a question I wish to ask the Minister of Indian Affairs and Northern Development.

Is the minister in a position to assert categorically that no decision has yet been made concerning the conversion of Coqualeetza Hospital into a community centre at the request of the Indians?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, it is with pleasure that I answer this question since the hon, member at the beginning of today's meeting rose on a question of privilege or on a point of order, in this connection. I must say that Mr. Bergevin, Assistant Deputy Minister for Indian and Eskimo affairs may have signed a letter on that date but he had not as yet put his recommendation to me. Since then, he did make a specific recommendation but I must inform the hon. member that the proposal submitted by that group of Indians in the area was not acceptable to the government since the group had promised that it would obtain funds from different sources both provincial and federal, and in the final analysis, the Indians were asking the government to foot the bill in full and at this moment we do not have the funds required for this.

Therefore, we were unable to accept the building which remains the property of the Department of National Health and Welfare.

Mr. Fortin: Mr. Speaker, I have a supplementary question.

The minister just stated that prior to writing his letter to the Indians Mr. Bergevin had not consulted him, which might explain his answer of March 24. Am I to take it that he is rejecting the contents of Mr. Bergevin's letter or is this letter still valid?

Mr. Chrétien: Mr. Speaker, since I received Mr. Bergevin's letter, I have written an identical letter to Mr. Wilbur T. Campbell.
