#### FORECAST UNEMPLOYMENT RATE FOR 1971

#### PROPOSED MORAN HYDROELECTRIC DAM ON FRASER RIVER—GOVERNMENT POSITION

**Mr. Mark Rose (Fraser Valley West):** Mr. Speaker, may I direct a question to the Minister of Fisheries and Forestry. It concerns the proposal to build a hydro—the Moran Dam—on the Fraser River. Has the government taken any position regarding this mooted dam? If so, what is the position of the government?

**Hon. Jack Davis (Minister of Fisheries and Forestry):** Because this very large dam would be built on an important salmon river which is also navigable, I am sure the federal government would be concerned about its construction.

**Mr. Rose:** Can the minister tell us whether he or his department has entered into discussions with the government of British Columbia concerning this matter?

**Mr. Davis:** We have appointed several of our officials who are knowledgeable in these matters to work with the British Columbia Energy Board on studies involving the development of all of the Fraser River system, including dams at various sites, such as the Moran Dam.
