I said in answer to the specific question asked by the Leader of the Opposition that I could not discuss what was before cabinet. I said on a number of occasions, both within and without the House, that decisions regarding government policy on foreign ownership had not yet been reached. The matter is still before cabinet. We have not yet made our decisions. The document that has been released suggests there was some tentative decision in principle. This may or may not be true. I cannot either deny it or accept it, but the decisions of the government as to its policy on foreign ownership have still to be made.
