## GUINEA BISSAU—ATTITUDE OF CANADA ON ADMISSION TO UNITED NATIONS

Mr. Andrew Brewin (Greenwood): Mr. Speaker, I wish to direct a supplementary question to the Secretary of State for External Affairs about Guinea Bissau. If the Canadian government is so anxious to be of assistance to independence movements, will the minister tell us what Canada is doing with regard to the initiative of many other nations to bring Guinea Bissau into the United Nations? How have we voted or how do we propose to vote on the admission of Guinea Bissau to the United Nations?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, the position we have taken on that question has so far been one of abstention. We are not opposed to the entrance of Guinea Bissau as soon as it is established as an independent country with a government that can discharge its international obligations.

NAME OF EXTERNAL AFFAIRS REPRESENTATIVE ON TECHNICAL ADVISORY COMMITTEE ON PETROLEUM SUPPLY AND DEMAND—ALLEGED CONTRADICTORY STATEMENTS

Mr. Sinclair Stevens (York-Simcoe): Mr. Speaker, my question is to the Secretary of State for External Affairs who has referred to his appearance before the Standing Committee on Miscellaneous Estimates. Can the minister explain his statement to that committee on December 3 that he was aware of who his departmental representative is on the technical advisory committee on petroleum supply and demand, bearing in mind his statement in the House on December 4 that he did not know who his departmental representative on that committee was and declined to name him?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, I am not quite sure whether it is in order to refer to what went on in committee, but perhaps I can answer the question directly. I am aware of the name of the official. He is a very competent one.

Some hon. Members: Oh, oh!

Mr. Sharp: But I suggest it is not appropriate to bring the names of officials who are acting on behalf of ministers into contention in the House of Commons. One ought to address one's questions to ministers.
