#### **PRIVILEGE**

MR. HNATYSHYN-ALLEGED INTRUSION ON RIGHTS OF MEMBERS—RULING BY MADAM SPEAKER

Madam Speaker: There is a matter pending before the House and that is a ruling that I should like to make concerning the question of privilege raised by the hon, member for Saskatoon West (Mr. Hnatyshyn). I heard his argument and I think I am able to rule on that question of privilege now.

The hon, member was arguing a very hypothetical situation. The will of the House certainly had not been expressed; therefore it could not have been crossed. Consequently, I do not think he has a prima facie question of privilege.

Mr. Nielsen: Madam Speaker, I have a very brief point of order. I believe there is a question of privilege on which the Chair reserved its ruling because the Minister of Indian Affairs and Northern Development might want to refer to it. In view of the rapidity with which ministerial offices are being established in Yukon by the Secretary of State, the Minister of Energy, Mines and Resources, and perhaps next an embassy by the Secretary of State for External Affairs, I do not want to appear to be rushing the Chair but perhaps a ruling might prevent any further proliferation of this practice.

Madam Speaker: I have some rulings ready. One is on that particular matter and there is another question which has been raised. I will rule on them tomorrow. I have several rulings for the House but I thought I would not occupy the time of the House more than need be. I will probably rule tomorrow on those questions.
