IMMIGRATION ACT, 1976

MEASURE TO AMEND

The House resumed consideration of the motion of Mr. Bouchard that Bill C-84, an Act to amend the Immigration Act, 1976 and the Criminal Code in consequence thereof, be read the third time and passed.

Mr. Marcel Prud'homme (Saint-Denis): Mr. Speaker, as I was saying last night... I am sorry, truth is always the easiest thing. Well, I just came in to join the procedural debate which, I thought, would last longer.

Last night I was saying that one of the roles of the Minister of Immigration (Mr. Bouchard)... And I am not directing my remarks to him personally because he is here this morning, but such is my idea of a Minister of Immigration. Like at the time I was arts critic I used to say that defending Cabinet decisions before the artistic community and people who are more directly involved in arts and who create hundreds of thousands of jobs was not the only role of the Minister responsible for arts in Canada. He also had to reflect and champion the concerns and wishes of that community before Cabinet, I am saying that as far as immigration is concerned, I think the situation is the reverse.

Indeed I began Monday morning during a TV program in Montreal—Mathias Rioux was the host—concerning immigration when I could have taken the easy way out . . . I know it
