pharmaceutical industry which made it possible for generic companies to copy various new drugs.

It was the current Leader of the Official Opposition (Mr. Turner) who, as the then Minister of Consumer and Corporate Affairs, introduced this Bill which proved so detrimental to Canadians.

Since that legislation, the pharmaceutical industry has declined in Quebec and Canada; Liberals have exported our jobs abroad instead of our goods and services. What is even worse, we, as Canadians, are no longer able to find here the most advanced medicines. Foreign companies refuse to sell them here for fear of their being copied.

However, because I still trust a number of Liberal Members, today I ask the Leader of the Liberal Opposition to allow the Hon. Member for Mount Royal, a physician, to deal with the legislation we have introduced keeping in mind her former clients as well as the three prosperous drug manufacturers in her riding of Mount Royal.

In a few minutes, Mr. Speaker, we will see whether the Liberal Leader is gagging his troups.

FORGET COMMISSION REPORT—MINISTER'S POSITION ON PRESENT SYSTEM

**Right Hon. John N. Turner (Leader of the Opposition):** Mr. Speaker, I have a question for the Minister of Emmployment

and Immigration with regard to the Forget Report. The Government tried to deindex old age pensions, it cut family allowances, and it is now going to raise drug prices as a result of the legislation currently before the House.

I believe the country has the right to know what the Minister meant when he said yesterday, "Admittedly, the present unemployment insurance system does call for changes". What does the Minister have in mind, or does he know what he has in mind?

Hon. Benoît Bouchard (Minister of Employment and Immigration): Mr. Speaker, obviously, the Government would not have bothered to create a commission, the Forget Commission which worked for over a year and a half in order to submit a certain number of recommendations to the Government, if it had not realized there were a number of things in the system that ought to be improved and should be given careful consideration in order to increase the efficiency of a system that costs us \$12 billion a year.

The report has been submitted, and the Government, as I said yesterday, is going to take a very careful look at all relevant studies so that on May 15, it will be able to give Canadians an outline of what it intends to do with the unemployment insurance system.
