WHEREAS it has now become expedient for the CBC to complete its chain of stations by the construction of a second high power station in Toronto to be used as the basic station of the Dominion Network, and of high power stations in Manitoba and Alberta;

IT WAS RESOLVED

THAT the Management be instructed to notify the Minister of Reconstruction that in accordance with its original plans the CBC will require the Class lA channels referred to above and will in due course apply to him for these particular channels which it considers necessary to the operation of its national service.

The meeting adjourned at 12,10 a.m.

NOVEMBER 28TH, 1945 (Morning Session)

The meeting opened at 10.15 a.m.

Discussion took place with regard to American commentators.

Moved by Mr. Sandwell, seconded by Dean Pouliot,

IT WAS RESOLVED

THAT the CBC revert to their pre-war policy, namely: that commentaries from other countries, to be broadcast over Canadian stations on a purely sustaining basis, be permitted and that commercially sponsored commentaries from other countries to be deemed sponsored opinion under the interpretation of the White Paper Policy be disallowed.

At 10.35 a.m. Mr. J. Sedgwick, Mr. Walter Harris, M.P., and Mr. Ralph Snelgrove, Manager of CFOS Owen Sound, came before the Board on behalf of the application for affiliation with the Dominion Network. Mr. Sedgwick read a brief in support of this application and explained that this station was willing to pay 25% of the cost of lines if this service was granted. Mr. Snelgrove pointed out, however, that the main purpose of having connection to the network was mainly to give the community CBC sustaining programs.

Mr. Sedgwick and Mr. J.J. Murray appeared before the Board at 11.00 a.m. regarding the transfer of ownership of radio station CFBR Brockville, from Mr. J.W. Whitby to Mr. Murray. Mr. Sedgwick informed the Board that he was appearing on behalf of Mr. Whitby who was unable to be present. He said Mr. Murray is an experienced radio man and is quite capable of operating a station. Mr. Whitby's health, he said, is such that he can no longer carry on and although he was selling out entirely, he intends to hold shares in the new company to be formed. The Chairman thanked Mr. Sedgwick for his presentation and informed him that his application would be considered.

At 11.15 a.m. Messrs. A. Dupont, Phil Lalonde of radio station CKAC and William Ensign of CBS, appeared before the Board in support of Mr. Dupont's application to permit his new station CJAD, which will be in operation shortly, to become affiliated with CBS. In the brief that was submitted it indicated that although CKAC was already carrying CBS programs, it only served the French speaking listeners as the
