Boston's hope for the North Atlantic Fishermen's Trophy races, scheduled to be held off Halifax next month, has been barred. The Mayflower, sleekest sailing fishing craft afloat, as some have styled the Hub flyer, which was selected by the American Race Committee as the defender of the cup won last year by the Esperanto, of Gloucester, is not acceptable to the Trophy Trustees at Halifax and unless a new defender is chosen there will be no international fishing schooner races off Halifax harbor this year.

Such in brief is the rather delicate situation that has arisen following the interchange of messages between Chairman Chas. D. Brown of the American Committee at Gloucester and Chairman H. R. Silver of the Trustees at Halifax. On Wednesday night Mr. Silver received word from Mr. Brown that the Americans had selected the Mayflower as defender of the Trophy, no other eligible boats having entered for the American elimination race. Yesterday afternoon, following a meeting of the Trustees, Mr. Silver sent the following telegram to Gloucester:

Brown, Chairman American International Fishermen's Race Committee, Gloucester, Mass.: Answering your telegram of fourteenth, I am authorized to inform you that the Trustees of the North Atlantic Fishermen's International Trophy who met to-day cannot accept the Mayflower as an entrant for the International Races off Halifax in October, and it will be necessary for you to find some other defender or let the race go by default.
