

By leave of the House,—

On motion of Sir Robert Borden, it was resolved, That Messrs. Chisholm, Lemieux, Loggie, Myers, Pedlow, Rowell, Stacey, Steele, Trahan, White (Sir Thomas), and Whidden, be appointed Managers on behalf of this House of the free conference with the Senate with respect to Bill 107, An Act to confirm the Order in Council of the twenty-fourth day of February, 1919, prohibiting the Importation, Manufacture and Transportation of Intoxicating Liquors, and the Order in Council of the twelfth day of April, 1919, in amendment thereof, and that a Message be sent to the Senate to acquaint their Honours therewith.

The House went again into Committee of the Whole on Bill No. 166, An Act to constitute a Board of Commerce for Canada, which was reported with amendments, considered as amended;

By leave of the House, the said Bill was read the third time and passed.

The Bill No. 167, An Act concerning the Investigation and Restraint of Combines, Monopolies, Trusts, and Mergers and the withholding and enhancement of the prices of commodities, was read the second time, considered in Committee of the Whole, and progress having been made and reported, the Committee obtained leave to consider it again, this day.

A Message was received from the Senate informing this House that the Managers of the free conference on the part of the Senate on Bill No. 107, will meet in the Senate Committee Room No. 70, at 10.30 o'clock, a.m., the fifth day of July, instant.

At Six o'clock, p.m., Mr. Speaker left the Chair, to resume the same at Eight o'clock, p.m.
