land canal, and are these surveys completed? If not, what amount is estimated to complete?

Mr. GRAHAM:

(a). About twenty thousand dollars have been spent in surveys to ascertain the most desirable route for the possible new, or enlargement of the old Welland canal.

(b). These surveys are not completed. It is estimated that twenty-five thousand dollars will be required to complete them.

EXPENSES RE QUEBEC BRIDGE.

Mr. FOSTER:

What has been the cost for engineering, xamination, reports, preparation of plans examination, and specifications incurred, since August 29, 1907, in connection with the Quebec bridge?

Mr. GRAHAM:

(a). The total cost of the commission in connection with the inquiry into the collapse of the Quebec bridge was \$31,765.44.

(b). The total cost to December 31, 1909, of the board of engineers in preparation of plans, etc., was \$123,469.03.

WHARF AT CANNING.

Mr. TAYLOR:

1. Has the government built a wharf at Canning? If so, when was it finished, and what is the total cost?

2. Has a wharfinger been appointed therefor? If so, when and at what salary?

3. Have any tolls been collected thereon? If so, to what amount each year?

Mr. PUGSLEY:

(a) Yes, a wharf is being built affording accommodation for railway as well as general traffic on the Habitant river; total and highway length, including railway approaches along the river bank, about 900 feet; the sum of \$2,000 being still required to complete work now under construction. (b) Total cost, \$33,867.33. The site was contributed by the riparian own-

ers free of charge.
2 and 3. No. When the work is finished and the spur line of the Dominion Atlantic railway installed thereon, a whar-

finger will be required.

4. Yes, a small temporary warehouse built by the Minas Basin Steamship Company

at an approximate cost of \$100.

5. Yes. Three public roads and an open private way connect this wharf with Main street, and another public road connects it with the settlements to the southward. Besides this, the Dominion Atlantic railway has undertaken to build a spur line or railway from its line to and along the water front of the wharf.

6. A subsidized steamer owned by the Minas Basin Steamship Company runs regularly to St. John, New Brunswick, and Minas Basin ports. Large vessels load potatoes for the West Indies; apples and other products are loaded for various ports and return cargoes received.
