1. When were bounties first provided for on the production of copper bars and hemp twine in Canada?

2. Where are the factories located for the production of these commodities and what was the amount paid in bounties on such production in 1925, 1926 and 1927?

Mr. MALCOLM:

1. The bounty on the production of copper bars dates from May 12, 1923. The bounty on hemp twine dates from January 1, 1926.

2. Bounty on copper bars or rods—Consolidated Mining & Smelting Co., Trail, B.C.: Paid, 1925-26, \$14,822.67; 1926-27, \$164,242.30; 1927-28 to February 4, \$73,604.92.

Bounty on hemp—Doon Twines Ltd., Kitchener, Ont.: 1927-28 to February 1,

\$285.72; Consumers Cordage Co., Ltd., 283 St. Patrick street, Montreal: 1927-28 to February 1, \$74.18; Manitoba Cordage Co., Ltd., Portage La Prairie, Man.: 1927-28 to February 20, \$1,025.92.
