MAINLAND CHINA—DUMPING DUTIES ON  
IMPORTS UNDER QUOTA

**Mr. Nicholas Mandziuk (Marquette):** Mr. Speaker, I should like to direct a question to the Minister of Finance. Are imports coming into Canada under an agreed quota subject to dumping duties?

**Mr. Speaker:** Order, please. I do not believe that question is acceptable. The hon. member seems to be asking a question of a very general nature and is perhaps asking for a legal interpretation. Certainly, the way he has phrased the question now, I do not see how it can be asked.

**Mr. Mandziuk:** May I be more specific. Are dumping duties charged against imports coming in under quota from mainland China, our good wheat customer? I think the Minister of National Revenue or the Minister of Finance is capable of answering that question.

**Mr. Speaker:** Perhaps the question may be a little more clear now but I still feel that it cannot be asked at this time.

**Mr. Mandziuk:** Mr. Speaker, my question deals with a subject previously raised. I was in the right church but in the wrong pew. Rephrasing a question I asked previously, may I ask the Minister of National Revenue whether he would not give consideration to removing dumping duties on goods coming into Canada from mainland China under a certain quota? I have in mind such items as cloth, suiting, or what have you.

**Mr. Speaker:** Order, please. I think this is a question of general policy, and I doubt whether it should be asked.

**Mr. Mandziuk:** With all due deference, Mr. Speaker, this is a question of policy. I should like to know about the matter, because I
