DRAFT DODGERS FROM U.S. FORCES SEEKING ASYLUM IN CANADA

On the orders of the day:

Mr. R. W. Prittie (Burnaby-Richmond): Mr. Speaker, my question is directed to the Secretary of State for External Affairs. Have there been any cases of young Americans who have refused to serve in the United States forces in Viet Nam having come to Canada and asked for political asylum on that ground? If there have been such cases, has political asylum been granted?

Hon. Paul Martin (Secretary of State for External Affairs): I know of no such case, Mr. Speaker.

Right Hon. J. G. Diefenbaker (Leader of the Opposition): A supplementary question, Mr. Speaker. Would the minister look this up, because it has been advertised in the press over and over again that there is a group in British Columbia, and I think one in Ontario. whose object it is to welcome draft dodgers? Will the minister find out why these people, not being willing to assume the responsibilities of their own citizenship, should be welcomed as good citizens here?

Mr. Martin (Essex East): I will be very glad to look into the matter, Mr. Speaker. I doubt very much whether there is any foundation for the original question.

Mr. Diefenbaker: The minister, of course, has been abroad engaged in audacious proceedings, and has not been reading the press.

Mr. Martin (Essex East): I have generally found there a greater and more valuable foundation for questions asked in the house, Mr. Speaker.

Mr. Diefenbaker: That does not apply to your answers.
