Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, as you have said this is a question which requires interpretation of a statute. I will take the question as notice, but perhaps it would be better if the hon. gentleman were to place it on the order paper.

Mr. McIntosh: Have any discussions been held on this question between the authorities of the United States and Canada?

Mr. Sharp: I will have to take notice of that.

QUEBEC-EXPRESSION OF SUPPORT BY UNION

Since a labor leader stated in Quebec yesterday that he and his group backed strongly those perpetrating acts of violence in Quebec. or who intended to indulge in violence, is it the intention of the government to carry out an inquiry in this connection?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, while the Minister of Justice is in Vancouver for the purpose of carrying on the discussions on the Constitution under-

that this matter, as many others, comes under the administration of justice and does not, therefore, fall under our jurisdiction, unless we are asked by the province to intervene. L.S.D.—INVESTIGATION BY R.C.M.P. INTO ILLEGAL IMPORTATION

Could he tell the house whether the R.C.M.P. has been able to clarify the situation with regard to the smashing of an international drug ring wherein great quantities of l.s.d. were coming into Canada, and is there anything further he can tell us beyond what he did not tell the hon, member for Palliser some ten days ago?

Hon. G. J. McIlraith (Solicitor General): No, Mr. Speaker, I am not able to give the hon. member information at the moment, but I will look at the question to see if something can be given at a later stage.

Mr. Lambert (Edmonton West): As a supplementary question, Mr. Speaker, would the minister look into the question and advise whether the drug was being manufactured in Canada in Canadian government laboratories, and in particular was any employee of the government involved in its manufacture on behalf of the ring?
