Hon. Ron Basford (Minister of Consumer and Corporate Affairs): The government has received a number of communications from Robin Austin and John Fetherstonhaugh, Q.C., concerning sugar. (a) An inquiry has been commenced pursuant to sections 7 and 8 of the Combines Investigation Act. (b) and (c) See answer to (a).

- 1. How long does it take to process medical cases under the Canada Pension Plan?
- 2. Are district offices of the Department of National Health and Welfare advising applicants that cases may take up to six months to process?

Hon. John C. Munro (Minister of National Health and Welfare): 1. It is difficult to give a precise answer since the processing time varies considerably, depending on the circumstances of each case. Every effort is made to obtain the essential information, including medical reports, as quickly as possible.

- Hon. Donald S. Macdonald (Minister of National Defence): 1. No, however normal maintenance work is being done on existing runways and taxiways at an estimated cost of \$495,000.
