

*Order Paper Questions***Question No. 857—Mr. Epp:**

1. Who was the head or chief representative of the Cormorant Fishermen's Co-op in Manitoba at the time when the organization received funding under the Federal-Provincial ARDA Programme?

2. (a) How many people were employed as a result of the grant and for what period of time (b) how many are presently employed?

**Mr. Donald Wood (Parliamentary Secretary to Minister of Regional Economic Expansion):** The reply for the Department of Regional Economic Expansion is as follows: 1. In January of 1973, when Special ARDA assistance was offered to Cormorant Fishermen's Association, the head representative was Mr. Louis J. Ducharme, president.

2. (a) Three members of Cormorant Fishermen's Association were able to engage in commercial fishing during the contract period and improved their incomes as a result. (b) At the time of expiration of the contract on March 31, 1974, all members were still registered as commercial fishermen.

**Question No. 858—Mr. Epp:**

1. Who was the head or chief representative of the Indian Rice Producers in Manitoba at the time when the organization received funding under the Federal-Provincial ARDA Programme?

2. (a) How many people were employed as a result of the grant and for what period of time (b) how many are presently employed?

**Mr. Donald Wood (Parliamentary Secretary to Minister of Regional Economic Expansion):** The reply for the Department of Regional Economic Expansion is as follows: 1. In May of 1973, when Special ARDA assistance was offered, the head representative of Indian Rice Producers Co-op Ltd. was Mr. Walter Courchene, president.

2. (a) At the start of operations, the enterprise employed three people, but has since ceased operations due to bankruptcy. (b) See 2. (a) above.

1. Who was the head or chief representative of the Camperduck Trappers Association in Manitoba at the time when the organization received funding under the Federal-Provincial ARDA Programme?

2. (a) How many people were employed as a result of the grant and for what period of time (b) how many are presently employed?

**Mr. Donald Wood (Parliamentary Secretary to Minister of Regional Economic Expansion):** The reply for the Department of Regional Economic Expansion is as follows: 1. In October of 1972, when Special ARDA assistance was offered to Camperduck Trappers Association I, the head representative was Mr. George Butler, secretary-treasurer.

2. (a) Seven members of Camperduck Trappers Association I were able to engage in trapping during the contract period and improved their incomes as a result. (b) At the time of expiration of the contract on March 31, 1974, all members were still registered as trappers.

2. (a) Thirteen members of Wabowden Trappers Association I were able to engage in trapping during the contract period and improved their incomes as a result. (b) At the time of expiration of the contract on March 31, 1975, all members were still registered as trappers.

In June of 1973, when Special ARDA assistance was offered, the head representative of Tri-Star Construction was Mr. William Dumont, owner.

2. (a) From the start of operations to the end of the Special ARDA three-year control period, November, 1976, this enterprise employed three people annually. (b) As the control period of the financial assistance has expired and final payment has been made, this information is no longer collected.
