services to Fredericton north, Oromocto and Minto has been the subject of investigation by Employment and Immigration since January 1, 1978.

Currently Oromocto, which is located 12 miles from Fredericton, is covered by a two-day-per-week itinerant service to Canadian Forces Base, Gagetown, designed to assist long-term servicemen and officers to prepare themselves for a second career. Minto is served by a branch office which provides employment services and accepts unemployment insurance inquiries and applications.

An examination of the need for services in Fredericton north and Oromocto indicates that the residents of both localities have reasonable access to the main CEC, that the vast majority of job opportunities are in Fredericton and that there is an insufficient number of claimants to warrant the establishment of separate offices to provide unemployment insurance services.

The possibility of reallocating some resources from the Fredericton office to the centres in question has also been considered. However, it has been concluded that such moves would not significantly improve the service to the residents of these centres and would cause a serious deterioration of service at the main office.

EIC will continue to evaluate this situation in light of changing conditions.
