

He also laid before the House,—Copy of Ordinances of the Yukon Territory passed by the Yukon Council in the year 1933.

Also,—Statement regarding retirement of Thomas Mulvey, Esq., as Under Secretary of State of Canada pursuant to the provisions of Section 6 of the Civil Service Act, R.S.C., 1927, chapter 22.

Also,—Copy of Report of positions excluded under the provisions of section 59 from the operation of the Civil Service Act, chapter 22, R.S.C., 1927, from October 1, 1932, to December 31, 1933.

Also,—Detailed statement of all bonds and securities registered in the Department of the Secretary of State of Canada, since last return, submitted to the Parliament of Canada under section 32 of chapter 164 of the Revised Statutes of Canada, 1927.

He also presented,—Return to an Order of the House of the 6th February, 1933, for a copy of all correspondence in connection with the demotion of R. C. Maxwell, former Surveyor of Customs and Excise at Port of Vancouver.

Also,—Return to an Address to His Excellency the Governor General, of the 20th October, 1932, for a copy of all telegrams, correspondence, letters, reports and all other documents exchanged between the Director of Unemployment at Ottawa, and the Quebec Government, in connection with the application of the Unemployment and Farm Relief Act of 1930, 1931, and 1932.

Also,—Final Return to an Order of the House of the 13th February, 1933, for a copy of all letters, telegrams and other documents, exchanged between any members or officials of the Federal Government and G. G. Serkau or any other person or persons in connection with the proposed exchange of Canadian cattle for Russian goods.

Also,—Return to an Order of the House of the 15th February, 1933, for a copy of all correspondence between any member of the Government and Mr. G. G. Serkau or any of his associates in connection with the proposal to exchange Canadian cattle and hides for Russian commodities.

Also,—Return to an Order of the House of the 29th March, 1933, for a copy of all correspondence, documents and resolutions, emanating from Ex-Service Men's Associations throughout Canada dealing with veterans' unemployment relief, and received by the Prime Minister, the Minister of Pensions and National Health or the Department of Pensions and National Health, from October 1, 1932, to date.

Also,—Return to an Order of the House of the 3rd April, 1933, for a copy of all correspondence, telegrams, Orders in Council and other documents exchanged between any member of the Government, or departmental official, and any other individual, corporation or association, since September 1, 1930, relating to the following subjects, (a) duty on fuel oil imported into British Columbia; (b) bonus, subsidy or subvention on the production of coal from the coal mines of Vancouver Island, British Columbia; (c) importation of British coal into British Columbia, and steps to deal with the situation thereby created; (d) proposed sale or leasing of the Canadian National Railway docks at Vancouver.
