



PROCLAMATION

PROHIBITION PLEBISCITE.

Electoral District of Durham, West Riding, Province of Ontario, Dominion of Canada.

PUBLIC NOTICE is hereby given to the Electors of the Electoral District aforesaid, that, in obedience to Her Majesty's Writ to me directed and bearing date the Fifth day of August, 1898, I require the presence of the said electors at their respective polling divisions, on the

29TH DAY OF THE MONTH OF SEPTEMBER

next, for the purpose of taking a vote on the following question, to wit:

“Are you in favor of the passing of an Act prohibiting the Importation, Manufacture or Sale of Spirits, Wine, Ale, Beer, Cider and all other Alcoholic Liquors for use as Beverages.”

That a poll will accordingly be opened on the said Twenty-ninth day of the month of September next, from the hour of nine in the forenoon till five of the clock in the afternoon in each of the following polling divisions, to wit:

FOR MUNICIPALITY OF BOWMANVILLE.

- POLLING SUBDIVISION NO. 1, WEST WARD.—Comprising so much of the West Ward as lies South of Wellington Street and Second Concession Line, West of Seago Street, at Police Office, Town Hall.
- POLLING SUBDIVISION NO. 2, WEST WARD.—Comprising so much of the West Ward as lies North of Wellington Street and Second Concession Line, West of Seago Street, at T. C. Furniture Co's Office.
- POLLING SUBDIVISION NO. 1, NORTH WARD.—Comprising all the North Ward lying South of Wellington Street, at McMurtry's Livery Office.
- POLLING SUBDIVISION NO. 2, NORTH WARD.—Comprising all the North Ward not included in Polling Subdivision No. 1, North Ward, at Drill Shed.
- POLLING SUBDIVISION NO. 1, SOUTH WARD.—Comprising that part of the South Ward lying North of Albert and Prince Streets, at Fire Hall.
- POLLING SUBDIVISION NO. 2, SOUTH WARD.—Comprising that part of the South Ward not included in Polling Subdivision No. 1, at South Ward School House.

FOR MUNICIPALITY OF CARTWRIGHT.

- POLLING SUBDIVISION NO. 1.—Comprising that part of said Township, West of the original allowance for road, between Lots 12 and 14, 2nd, 3rd and 4th Concessions, at Town Hall, Blackston.
- POLLING SUBDIVISION NO. 2.—Comprising that part of said Township, East of the original allowance for road, between Lots 12 and 14, 2nd, 3rd and 4th Concessions, at Devitt's Orange Hall.
- POLLING SUBDIVISION NO. 3.—Comprising that part of said Township lying North of the 4th Concession and West of the original allowance for road, between Lots 16 and 17, at School House, Casarsen.
- POLLING SUBDIVISION NO. 4.—Comprising that part of said Township, lying North of the 4th Concession and East of the original allowance for road, between Lots No. 16 and 17, at Residence of A. Vesle, Esq., Nestleton.

FOR MUNICIPALITY OF CLARKE.

- POLLING SUBDIVISION NO. 1.—Comprising Lots No. 1 to 12 inclusive, from front of Township to the rear of 2nd Concession, at Tem Newtonville.
- POLLING SUBDIVISION NO. 2.—Comprising Lots No. 13 to 26 inclusive, from front of Township to the rear of 2nd Concession and 1st Concession, in the South Half of the 3rd Concession, at House of Timothy Hays, Esq., opposite Brown's School.
- POLLING SUBDIVISION NO. 3.—Comprising Lots 27 to 35 inclusive, from front of Township to the middle of 3rd Concession, also Lots North Half of the 3rd Con. and the South Half of the 4th Con. at House of Thos. Keat, Lot 29, 2nd Con.
- POLLING SUBDIVISION NO. 4.—Comprising Lots No. 1 to 16 inclusive, in the 6th Concession, and 1 to 14 in the 7th and 8th Concessions; also Lots 10th Concessions, at Orange Hall, Kendall.
- POLLING SUBDIVISION NO. 5.—Comprising Lots No. 17 to 30 inclusive, in the North Half of the 6th Con. and 17 to 35 in the South Half of the 6th Con., and village of Orono, North of Centre Street, at Walter's Blacksmith Shop, Orono.

- POLLING SUBDIVISION NO. 7.—Comprising Lots No. 15 to 24 inclusive, in the 7th and 8th Concessions, and from 13 to 24 inclusive in the 9th and 10th Concessions, at House of Fred. Riddle, Lot 23, Concession 8.
- POLLING SUBDIVISION NO. 8.—Comprising Lots No. 1 to 16 inclusive, in the 3rd, 4th and 5th Concessions, at School F, Lot 10, Concession 5, (Starkville).
- POLLING SUBDIVISION NO. 9.—Comprising Lots No. 17 to 35 inclusive in the North Half of the 4th Concession and South Half of the 5th Concession, and the village of Orono South of Centre Street, at Fire Hall, Orono.

FOR MUNICIPALITY OF DARLINGTON.

- POLLING SUBDIVISION NO. 1.—Comprising Lots 1 to 8 inclusive in the Broken Front Concession; 1 to 7 inclusive, in the 1st and 2nd Concessions; and Lots 1 to 12 inclusive, in the 3rd, 4th and 5th Concessions, at the House of A. Wight, Lot 7, Concession 2, (Providence).
- POLLING SUBDIVISION NO. 2.—Comprising Lots 1 to 12 inclusive, in the 6th, 7th, 8th, 9th and 10th Concessions, at Sons' Hall, Tyrone.
- POLLING SUBDIVISION NO. 3.—Comprising Lots 13 to 24 inclusive, in the Broken Front Concession; 15 to 24 in the 1st and 2nd Concessions, and 13 to 24 in the 3rd Concession, inclusive, at Sons' Hall, Maple Grove.
- POLLING SUBDIVISION NO. 4.—Comprising Lots 13 to 24 inclusive, in the 4th, 5th and 6th Concessions, at Town Hall, Hampton.
- POLLING SUBDIVISION NO. 5.—Comprising Lots 13 to 24 inclusive, in the 7th, 8th, 9th and 10th Concessions, at Potter's Hall, Enniskillen.
- POLLING SUBDIVISION NO. 6.—Comprising Lots 25 to 35 inclusive, in the Broken Front, 1st, 2nd, 3rd and 4th Con. at Sons' Hall, Courtice.
- POLLING SUBDIVISION NO. 7.—Comprising Lots 25 to 35 inclusive, in the 6th, 6th, 7th, 8th, 9th and 10th Concessions, at Bradley's School House.

FOR MUNICIPALITY OF NEWCASTLE.

- POLLING SUBDIVISION NO. 1, EAST WARD.—Commencing on the South at the Lake along the Highway between Lots 24 and 25, in the Broken Front, 1st and 2nd Concessions of the Township of Clarke, to the Northern limit of said village boundary; thence West along the Northern boundary to a line parallel to the centre of Mill Street; thence South to Mill Street through 2nd, 1st and Broken Front Concessions to the Lake; thence East along the margin of the Lake to the Highways between Lots 24 and 25, Broken Front Concession to the place of beginning, at Uglow's shop.
- POLLING SUBDIVISION NO. 2, WEST WARD.—Commencing from the centre of Mill Street at the lake, thence Northerly through the centre of Mill Street in the Broken Front, 1st and 2nd Concession to the Northern limit of the corporation; thence West along the said boundary to the West limits of the corporation; thence South along the Highway between Lots 30 and 31, through 2nd, 1st and Broken Front Concessions to the margin of the Lake; thence Easterly along the margin of the Lake to the centre of Mill Street, the place of beginning, at Town Hall.
