

WITHOUT SIGNATURE The disposition now attempted can not be effective in any way towards a final disposition of this part of the general investigation into freight rates constituting the whole structure rela-tive to its parts, and of the parts in relation to the whole. Only the fullest investigation of all parts of that struc-ture in every locality in Canada, with a view to harmonizing those parts in relation to the whole structure, will satisfy the plain requirements of the order-in-council and enable the board to function thereunder. All orders of this board, dealing with rate matters, before signature, are by the long and safe practice of the board, required to be approved and bear the initials of the chief traffic officer of this board. 




