### LITTLE HEADWAY MADE IN CASE OF "GAMBALS BLUEBEARD"

#### Frenchman Charged With Disappearance of Thirteen Women to Whom He Had Promised Marriage—Gives Flippant Replies to Judge.

Paris, Sept. 14.—(Correspondence of The Associated Press.)—Little headway has been made in the case of Landru, "the Gambals Bluebeard," as the French papers term him, who charged by the police with being responsible for the disappearance of thirteen women to whom he had promised marriage.

The police have been investigating for four months and four times a week Landru is taken from the prison of La Santé to the office of Judge Bonin whose questions as to the fate of the thirteen women elicit from Landru evasive and at times very witty responses. They have got so far as to sweatheart number three and Landru's flippant replies have nearly driven the judge to nervous prostration.

Yesterday the judge announced that he was going for a holiday. Landru immediately slipped in with the request that he be permitted to take a vacation as the regime of La Santé did not agree with him. Might he not be allowed to go to his villa at Gambals and hold himself at the disposal of the Court? It was from Gambals villa that Landru's wife and two daughters disappeared never to be heard of since.

Judge Bonin was asking Landru this week how it was that his son who assisted him in removing the furniture of three of his fiancées did not make queries when moving that furniture in six months. "Did he not find it strange?" asked the judge. "My children obey my orders, they do not discuss them," responded Landru. "I have my misgivings as to the way you bring up your children, Judge," he added sardoniously.

Landru contended that he had an order from Mrs. Guillin, drawn up in legal form giving him full power of attorney to administer her property. "This document was not found among your papers, therefore, I must conclude that it never existed," said the judge.

Not one vestige of the missing women has been found and the charge of murder against Landru is growing weaker. "There is no 'corpus delicti' in the villa at Gambals in the vicinity of the villa have been drained, but it would appear as if the women have vanished into the air, no questions as to the probable whereabouts of the missing women, his relations with them prior to their disappearance, Landru invariably replies: "I am a man of the world, I cannot betray the confidence of women."

### Laboring Men Are Wanted In France

#### Soldier Who Arrived Yesterday Says 10,000 Men Are Wanted In France for Building Work.

"There is a great chance for the laboring man in France today," declared one of the St. John boys who returned from overseas yesterday. "There is all kinds of work to do, and not many people to do it, so of course the wages are high and the duties not very hard."

"Just before I left the reserve camp I heard that there was a call out for as many Canadian troops as would answer—they really wanted 10,000—to go to La Belle, France, and engage in the structural work and other building jobs. All kinds of inducements were held out, and the pay offered was \$7 a day, to start."

"Not only in France, but practically every country that was in the war zone, will need a lot of attention in the coming years and there should not be any lack of employment of a man anywhere, for if he cannot get work at home here in Canada or the United States, there is the big desolate land overseas that cannot be made right until the workers again flock to the fields, the mills, the shops, the factories and the building sites—and many of these former workers are sleeping the last sleep."

"It seems a queer thing to me to see the unrest and dissatisfaction among the working people of Canada. I have heard a lot about it while I was overseas, and I suppose now that I am home I will see a lot of it, but it does seem peculiar that Canada, that was so slightly affected by the war in a territorial and material sense, is having so much internal trouble, while Belgium, France, Italy, Serbia, Montenegro and the other countries are leading all their endeavors to restoring the wastage wrought to their country."

"To the boys who were overseas, spent four or five years there and are now expecting to come back to their homes and families, it does not seem right that the land should be deserted by workers who are mostly of alien birth—foreigners who did not fight for the freedom they enjoy, who do not pay anything towards defraying the expenses of the war or the upkeep of the troops overseas. Yet these parasites are drawing the highest wages and building the working man to rebel for higher wages and forcing up the cost of living again—and you can rest assured the agitator does not lose anything by the trouble caused."

"As far as I am concerned, I am going to give my own hand a try out, but I do not have the prospect of a good job at good pay over in France, and if things don't suit here, I'm going back there—tout suite."

### STEAM YACHT COLONIA IN PORT Beautiful Craft Owned by Rear Commodore Dearborn of New York Made Impression on All Who Viewed Her Yesterday.

Portsmouth, Ireland, Aug. 25.—(Correspondence of The Associated Press.)—Salvaging \$35,000,000 worth of gold and bullion from the White Star liner Laurotic is reported to have carried when she was sunk the night of January 28, 1917, off Funk Light, one of the northwestern coast of Ireland at the entrance to Lough Swilly, is being conducted by the salvage ship "The Prince of Wales," a ship of 2,000 tons, owned by the British Government.

The prince's cargo, lay at a depth of twenty-two fathoms. ### Soldiers Civil Re-Establishment

#### Department Reports 1,728 Tubercular Patients, 697 Insane and 4,307 Medical and Surgical Patients in Hospitals—5,070 Patients in Outside Clinics.

According to a report furnished by the Department of Soldiers' Civil Re-Establishment, there are at present 1,728 tubercular patients, 697 insane patients and 4,307 medical and surgical patients in hospitals receiving treatment in outside clinics. Since the inauguration of the department, 18,754 amputation and foot treatment cases have been given service, 3,459 amputation cases have been fitted with artificial limbs and 3,076 pairs of boots of special design have been provided.

In regard to vocational re-training, there are now in classes some 11,955 men, or about 8,000 since last year. Nearly 4,500 have been graduated from these courses and 80 per cent. of the number report that in their new employment they are earning as much or more than when they enlisted.

While the ex-soldier in training, both himself and his dependents are under new from the government. In Canada the single man without dependents receive \$60 a month; in the United States the remuneration is \$65; in England the amount is \$38.46.

In the case of married men, with dependents, Canada pays \$85 a month, the United States \$75 and England \$38.46.

The information and service branches of the department report that 207,381 returning soldiers have been interviewed with the idea of giving all information and assistance possible towards placing the fighter in the ranks of civilian workers again. Some 58,946 applications for employment have been received, and of these 50,558 had been placed satisfactorily. Free government employment offices have been established in eighty-nine centres from Sydney to Vancouver.

The British Consul-General at Chicago sent the following telegram: "On behalf of the British Government, I hasten to express sincerest sympathy on the death of your son, from the effects of gas and wounds received in action."

### Memorial Service To Nursing Sister

#### Interesting Ceremony in Charlotte Street Church Last Evening in Memory of Lenora May Jenner Who Died in England.

An interesting ceremony took place in the Charlotte street Baptist church Sunday evening when a memorial to Nursing Sister Lenora May Jenner was unveiled by her brother Burton Jenner, a returned soldier.

"To the glory of God, and in loving memory of Lenora May Jenner, daughter of Pastor J. H. Jenner, nursing sister in the Army Medical Corps, who died in England while on duty in the great war on December 13, 1918, aged twenty-three years. She had done what she could."

Rev. D. J. MacPherson, who conducted the memorial service, preached an impressive sermon, in the course of which he gave a brief account of the career of the nursing sister.

Miss Jenner was born at Brookville, Queens county, in 1895, and finished the broken run of the circle of life here on December 13, 1918. She was in her twelfth year when the family moved to Halifax. Three words, said the preacher, might be employed to give expression to her character. They were: life, love and loyalty.

With her life was a joy and a duty to the end. She was full of energy, and this energy found expression in cheerfulness, and in what she undertook to do and in her general view of life. Whatever she did, whether work or play, she did it with all the force of her being. It is possible that if she had been willing to spare herself she might have been alive today. On the day of the fatal explosion in Halifax she was hurt internally, but forgetting herself she persisted in maintaining to others, and without food she labored till exhausted at four o'clock in the afternoon.

Miss Jenner, who was a graduate nurse of the Winnipeg General Hospital, went to England in July, 1918, as a military nurse, and though hardly recovered from her injury in Halifax threw herself into the work of caring for the sick and wounded with her customary zeal and energy. Though her heart was in the work she was compelled by suffering to resign and was preparing to come home when she had to submit to an operation in a London hospital. The operation was successful, but a few days after she died and was buried with military honors at Brookwood, a beautiful place near London.

On a recent visit to England Deacon D. C. Clarke visited the place and at the same of the family placed a plant of Gramma on the grave.

### Encouraging the Sheep Industry

#### INDUCEMENT TO USE A PURE BRED RAM AT THE HEAD OF YOUR FLOCK OF SHEEP

The New Brunswick Department of Agriculture are co-operating with the Dominion Live Stock Branch in encouraging the use of Pure Bred Rams.

Persons Eligible. Any sheep raiser who purchases a pure bred registered ram and who has not before at any time used a pure bred ram in his own flock shall be entitled to a premium of ten dollars the first year; five of which will be paid by the New Brunswick Department of Agriculture and five by the Dominion Live Stock Branch, and an additional premium of Five Dollars the second year, payable by the Live Stock Branch. Applications for premiums to be sent in to Live Stock Division, Department of Agriculture, Fredericton, not later than December 1st.

Co-operative Purchasing of Pure-Bred Stock. The Dominion Live Stock Branch will pay the travelling expenses to any point east of Port William, Ontario, of any accredited man appointed by a Society, group of Societies or group of farmers who have orders to purchase at least twenty-five pure bred rams for farmers never having used a pure bred before. This same person has the privilege of making purchase of other live stock or rams for any farmer while on the trip, so long as the minimum of twenty-five rams are purchased as outlined above.

Grading of Pure-Bred Rams in New Brunswick. The services of Professor Saville, of Ontario Agricultural College, have been secured to visit each pure bred breeder in the province and classify the rams offered for sale into three grades—superior, average and common. By purchasing your rams in the province, farmers can write any breeder of pure bred sheep and be sure of getting the class of ram he applies for. New Brunswick is the first province to adopt this classification system. Breeders and purchasers stand to gain by it. The number of rams for sale together with the price and grade will be listed with the local Live Stock Division.

Boys' and Girls' Sheep Clubs. In order to create a deeper interest among our farm boys and girls in the business of sheep raising, arrangements have been completed to organize Sheep Clubs in the province. Members must be between the ages of ten to eighteen years. Ten members will constitute a Club. Two grade shearing ewes will be the number allotted to each. Members can get credit from any bank for the purchase price of sheep for one year at a per cent interest. The Department will arrange a fair at which prizes will be given. The Department will loan a pure bred ram to any Club with twenty ewes.
