

“ That an Act passed 3d Vict. cap. 21, ‘ An Act to continue an Act in addition to an Act, intituled An Act to repeal all the Laws now in force for the organization and regulation of the Militia, and to make further provisions for the same,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 22, ‘ An Act to continue an Act to authorize the Justices of the Peace in the County of York to make further provision for the payment of the Treasurer of that County,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 23, ‘ An Act to authorize the Grand Jurors of the several Counties within this Province to inspect the Public Accounts,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 24, ‘ An Act to continue the Act to regulate the Inspection of Dry and Pickled Fish for home consumption and for exportation,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 25, ‘ An Act to continue the Act relating to Church Wardens and Vestrymen, and to persons having voices in their election, so far as relates to the Parish Church of Saint Andrews,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 26, ‘ An Act to continue an Act relating to the Navigation of the Inner Bay of Passamaquoddy,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 27, ‘ An Act to continue the Act for the more speedy and effectual punishment of persons keeping Disorderly Houses,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 28, ‘ An Act to regulate the Assize of Bread in the Towns of Saint Andrews and Saint Stephen, in the County of Charlotte, and to repeal the Acts now in force relating to the Town of Saint Andrews,’ will expire on the 25th March, 1845.

“ That ‘ An Act to continue an Act, intituled An Act (passed 3d Vict. cap. 29,) to repeal the Laws now in force for appointing Firewards, and for the better extinguishing Fires in the Town of Saint Andrews, and to make regulations more suitable to the said Town, and for other purposes therein mentioned,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 31, ‘ An Act to continue the several Acts now in force relating to Insolvent Confined Debtors,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 33, ‘ An Act to amend and continue an Act, intituled An Act for the appointment of Firewards, and the better extinguishing of Fires which may happen in that part of the Parish of Saint Stephen commonly called Mill Town, and its immediate vicinity,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 34, ‘ An Act to continue the Act to provide for the collection of County and Parish Rates,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 47, ‘ An Act to repeal all the Acts regulating Tavern Keepers and Retailers, and to make other provisions in lieu thereof,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 55, ‘ An Act to continue an Act for the better regulation of the Office of Sheriff in this Province,’ will expire on the 1st April, 1845.

“ That an Act passed 3d Vict. cap. 62, ‘ An Act to make more effectual provisions for the regulation of Seamen in this Province,’ will expire on the 1st April, 1845.

“ That an Act passed 4th Vict. cap. 5, ‘ An Act to authorize the Justices of the Peace in certain Counties in this Province to exempt the French Inhabitants from the assessment of Poor Rates,’ will expire on the 1st April, 1845.

“ That an Act passed 4th Vict. cap. 8, ‘ An Act to continue an Act, intituled An Act to provide for the summary punishment of persons committing trespasses upon Square Timber and other Lumber,’ will expire on the 1st April, 1845.
