have since been tied by passing threads through from the outside of the face. This controlled the hemorrhage. The bullet has not been lo-cated as yet and will not be at present until it causes or threatens to cause trouble where it is. Dr. Russell and myself agree that the patient is doing as well as could be expected under the circumstances. He is in an excellent condition and the prospects for his recovery are very promis-ing. But it is impossible to tell definitely in

cases of this kind for at least 48 hours."

Story of the Tragedy.

The story leading up to the shooting is in substance as follows: Shortly before 7 o'clock this

morning Chappel appeared at Whitney's second hand store and offered to sell a lot of cutlery that he carried in a sack under his overcoat. Whitney divining that the goods had been stolen induced Chappel to leave the stuff behind for examination, telling him to return by 8 o'clock and he would decide whether he wanted to buy or not. s soon as Chappel went out Whitney sent word McPhee, who soon appeared at the store. Judging from Chappel's appearance that he was a desperate character and fearing he might wreak vengeance upon him if identified with

his capture, Whitney arranged with McPhee that Chappel should be captured somewhere on the outside. Under these plans when Chappel re-turned McPhee waited for him on the outside.

Chappel then came out and went east on Spra-

He made directly across the street and through the Sloane Paine-Richmond company's store. He shed his overcoat on the run, but still retained the revolver in his hand. He was closely pursued and took refuge in an outhouse across the track between Howard and Stevens streets.

Here he was held at bay until Deputy Sheriff Jerguson arrived. When ordered to come out a shot was fired from within. Ferguson returned the shot under the impression that Chappel was firing at him. Waiting a moment and hear-ing no sound from within the officer looked in blood and brains oozing from a gaping wound in his right temple.
