Another Pacific Scandal.

The Toronto Globe of Friday last published an article giving the particulars of another scandal involving in enormity that in which the late Sir John A. Macdonald, and which caused the overthrow of the Tory Government of that day.

Those who were present at the large amount of money known to have been used in behalf of the Tory candidates in the election last year, and who wonder at what it had all come from, will understand how those things are managed after reading the *Globe's* article, and the charges it brings against the Dominion Government.

The *Globe* accuses the Dominion Government of having caused the expenditure of large sums of money in the Dominion elections last year and in the Ontario elections in the present year.

The firm spoken of is composed of Alex. Manning, of Toronto; Peter McLaren, of Perth; John Shields, of Toronto, and J. J. Macdonald, and, although Manning and McLaren are the managers of the firm, the whole management of the business of the firm was, at the instance of the Government, it is alleged, and for reasons which will now be apparent, placed in the hands of Shields and Macdonald.

Shields is one of the most prominent men in Ontario, and is a born friend of the Premier. He acted as the go-between in the notorious case of Gen. Hewson vs. Sir John, and generally he has been regarded as the "right hand" of Sir John in all matters "requiring to be kept from the light of the sun," as the *Globe* puts it. It is easy, therefore, to understand the motives which led to his being chosen as the purse-bearer of the Government.

The *Globe* says:— "Whether Shields and Macdonald made the overture or received them the broad statement, that they were not to be used to aid the Conservative candidates in the Dominion elections of 1882 and the Ontario elections of 1883.

In a single instance they withdrew Forty Thousand Dollars from the purpose of the election, and the money was not to be used to aid the Conservative candidates in the Dominion elections of 1882 and the Ontario elections of 1883.
