MADAME GALLI-CURCI TO SING IN LONDON

Smallest City in Which the Famous Singer Has Ever Sung.

Madame Amelia Galli-Curci, the great and only Galli-Curci, declared since the death of Caruso to be the world's greatest vocalist, will sing in London in the Grand Opera House on the evening of September 5. London will enjoy the distinction of being the smallest city in which Galli-Curci has ever sung in public since her career began, and sentimental reasons have much to do with her appearance here.

London is the home town of Angelo and Joseph Cortese, famous throughout America as violinist and harpist, respectively, and for some time past conducting a concert bureau and often after Galli-Curci has been splendidly received at southern concerts arranged by the Cortese brothers, they have reminded her that some day they wanted her to sing in their home town, so that their mother might hear her. Galli-Curci was born in Naples, also the birthplace of Angelo Cortese, and so many times she promised that some day she would sing in London.

She will appear here on her return journey from a western concert tour before opening her season at the Metropolitan Opera in New York. With her will be her present husband, and her two sons, Homer Samuels, and Emilie Berger, flutist, said to be the only musician in the world who plays on a flute of solid gold.

COUNTY ADOLESCENTS FIND IT DIFFICULT TO GET PERMITS

London Township Council to Take Action on Matter Today.

The adolescents between the ages of 14 and 16 years whose homes are in rural districts surrounding London, but who are employed in this city, are finding it difficult to obtain permits for employment certificates under the adolescent school attendance act, is the statement of Dr. G. S. Wain, school attendance officer for London.

Dr. Wain informed The Advertiser today that many of these adolescents have called upon him, but that he has no power to issue certificates to them in the meantime their employment certificates are not being issued.

Many of these youths will be required to journey to their home districts to obtain the necessary certificates, he points out, and in some cases there is no school attendance officer or similar official appointed to issue them.

I have received many applications for employment certificates from adolescents residing in Manor Park and from other districts of London Township, who are employed in this city," said Dr. Wain.

"I have informed Miss M. Grant, township clerk, of these cases, and she states that the matter will be considered at a meeting of the London township council today.

Dr. Wain has offered to issue certificates to such adolescents employed in London to save them trouble, but no action has as yet been taken by the township.

JAPANESE MERCHANTS SEEK BUSINESS HERE

Prefer to Deal Direct Than Through Their Own Countrymen.

That the Japanese businessmen put little faith in other businessmen in this country was evinced by a "quaintly written letter received this morning by the local chamber of commerce from Marui Shoten, a porcelain manufacturer, of Gifu-Ken, Japan. Because his firm distributes the jobs and exports of its own country it is seeking to build up a direct exporting department, and it, therefore, has asked aid from the local chamber of commerce.

Mr. Shoten stated that his firm has been manufacturing utility and fancy porcelain for 40 years at the most active centre of porcelain production in Japan. The market for their products has been chiefly located in Nagoya, where the goods found an outlet through middlemen. His opinion of the middlemen is as follows:

"But so dishonest and insincere as they are to ask for private commissions or other unreasonable discounts, quotations from what they were really offered made us, manufacturers, unable to do business with them. So we, the exporters, have decided to open an export department, although we know that it will likely induce unwelcome feelings, and we may lose the business, which is the greatest part of our business."

Preferential Trade Within Empire Is The Best Protection

Chairman of British Empire Council of Producers Told Chamber of Commerce Today—Unseen Hand Is Still Felt On British Trade, He Declared.

Ben H. Morgan, chairman of council, British Empire Producers' Association, who is touring Canada to investigate the needs of foreign business and as a means of making each colony strong within itself.

The vast importance of preferential trade within the British Empire was stressed upon his hearers. He pointed out that the Empire as a whole is a sure weapon to protect the interests of foreign business and as a means of making each colony strong within itself.

"England is still, foolishly, I think, a free trade country," he said. "By this I mean, all foreign countries have equal rights with the British colonies and the markets of Great Britain. This freedom has brought foreign products to the British markets to compete with British-made goods."

Unseen Hand, Felt. "In all of the large cities of Great Britain there are colonies of foreigners, including bankers, brokers and other influential businessmen. They have been chiefly located in Nagoya, where the goods found an outlet through middlemen. His opinion of the middlemen is as follows:

"But so dishonest and insincere as they are to ask for private commissions or other unreasonable discounts, quotations from what they were really offered made us, manufacturers, unable to do business with them. So we, the exporters, have decided to open an export department, although we know that it will likely induce unwelcome feelings, and we may lose the business, which is the greatest part of our business."

Yesterday afternoon police received word that two suspicious characters were loitering around Belmont Village. The people in that vicinity had become greatly alarmed because of their actions. Investigation showed them to be two discharged soldiers, one from the Canadian army and one from the American army, who had been released from home to Toronto and Winnipeg. They slept in a box car on a sliding rail afternoon, and started their escape by going to board a midnight freight for the east. They did not resemble the jail breakers.

Nothing In Story. Later in the day the crew of train No. 83, Grand Trunk, brought a report to London that the two escapees had been arrested at Sunnyide, a suburb of Toronto. In answer to a wire from London, the Toronto police stated that there was no truth in the rumor. Late last night Senior Inspector William Greer of provincial police, who was here on Sunday regarding an investigation into the conduct of affairs at the jail, was contacted by a report on the circumstances surrounding the jail-breaking.

Many Wild Rumors Continue To Reach Police Officials. The direction which Sidney and William Murrell took after they jumped from the jail wall on Friday evening and their present whereabouts are both mysteries to the police. This morning they were as completely free from the law as the first bandit was one day after the killing of Russell Campbell at Melbourne last April.

TECHNICAL AND HIGH SCHOOLS' ATTENDANCE BIG

Enrollment This Morning Surpasses That of Former Years.

Increased attendance over former years was noted at both the Technical School and Collegiate Institute, which opened for the fall term here this morning. With upper and middle school pupils, numbers not estimated, to report this afternoon, Principal W. H. T. Mooney of the Collegiate Institute informed The Advertiser that approximately 640 lower school students presented themselves this morning.

Of this number 350 are first-year students, or in other words are new arrivals at the Collegiate, while 290 enrolled in the second year. Eleven first-year classes will be formed, the attendance warranting such action.

"We provided for twelve classes which is our first-year limit, ready for an emergency," Principal Mooney stated to The Advertiser at noon today. "But find eleven classes are sufficient for the first year. Everything is lovely, and we are away to a fine start. The middle and upper school pupils who will augment the 640 attendance figure report this afternoon at 2 o'clock.

"Of course there will be more pupils enrolling next week, with perhaps a few stragglers after the fair. The attendance to date is greater than usual."

Surpassing last year's attendance figures by more than 100, approximately 500 pupils reported at the Technical School this morning, according to Principal H. B. Beal. This includes commercial department high school students, which department is now affiliated with the Technical School.

Both Principal Mooney and Principal Beal report that all members of their respective staffs, including those recently appointed, were on duty this morning in preparation for the commencement of the academic year.
