CANADA'S CONTRIBUTION TO THE INTER-AMERICAN DEVELOPMENT BANK

Question No. 2,050-Mr. Robinson:

What has been Canada's contribution to the Inter-American Development Bank and what are the interest and repayment arrangements?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Canada has not made any contributions to the Bank, as such. However, as of September of this year, Canada has made available to the Inter-American Development Bank a total of Cdn. \$60 million for projects to be administered by the Bank upon approval by Canada. This amount has now been fully committed. Canada has recently agreed to make available an additional Cdn. \$14 million for projects suitable for Canadian financing which brings the total allocation to Cdn. \$74 million. Normally loans are for 50 years including a 10-year grace period at zero per cent interest. The Bank charges a 0.5 per cent commission charge on the loans.

- 4. Selection is made on the basis of the overall suitability of the individuals experience and personal qualifications in relation to the requirements of the position.

6. The functions of the regional desks are to improve the liaison between the Prime Minister and those voluntary organizations which concern themselves with issues and problems common to many Canadians; to act as an additional source of information and advice to the Prime
