JURISDICTION OVER WATERS ABOVE CONTINENTAL SHELF—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

Mr. John Lundrigan (Gander-Twillingate): Mr. Speaker, I want to move a motion under Standing Order 43. I have served notice to the various parties and to the House leader of the party across the aisle who I understand has been in discussion with the Minister of the Environment and Fisheries, the Secretary of State for External Affairs and the Prime Minister.

Because of the public statements of the Minister of the Environment and Fisheries outside the House over the weekend supporting the concept of Canadian control of the marine resources of the continental shelf, and because of the consistent position of this party and the other parties of this House on this issue for some years, and in order to get the House to express its support of such a resolution, I ask for the unanimous consent of the House to move, seconded by the hon. member for Dartmouth-Halifax East (Mr. Forrestall):

That this House supports the concept of the jurisdiction of Canada over the waters superjacent to its continental shelf and that this position form the basis of Canada's presentation at the upcoming Law of the Sea Conference.

Mr. Speaker: The motion proposed by the hon. member for Gander-Twillingate requires the unanimous consent of

Perhaps these discussions might be resumed later on with a view to bringing this matter before the House in some other way.
