SUBJECT MATTER OF QUESTIONS TO BE DEBATED

Mr. Deputy Speaker: Order. It is my duty, pursuant to Standing Order 40, to inform the House that the questions to be raised tonight at the time of adjournment are as follows: the hon. member for Lethbridge (Mr. Hurlburt), Airports—Lethbridge—Suggested extension of runway; the hon. member for Assiniboia (Mr. Knight), Grain—Provision of cars by railways to transport wheat; the hon. member for Scarborough East (Mr. Stackhouse), Air Canada—Request that Canadian aerospace industry be considered in purchase of new planes.

It being five o'clock, the House will now proceed to the consideration of private members' business as listed on today's order paper, namely private bills, notices of motions (papers), public bills.

Mr. Foster: Mr. Speaker, I believe there is general agreement on both sides of the House to proceed with private members' public Bill C-228 standing in the name of the hon. member for LaSalle, relating to a change in name of his constituency. Following that, which I think will only take a few minutes, we could proceed to private bill S-7, standing in the name of the hon. member for Welland and entitled an act respecting The National Dental Examining Board of Canada.

Mr. Deputy Speaker: I take it from the remarks of the hon. member for Algoma that it is the wish of the House to deal with the bill at all stages, in view of his reference to a few minutes. If I am correct in that, I would not have to ask unanimous consent of the House.

ELECTORAL BOUNDARIES READJUSTMENT ACT**CHANGE IN NAME OF CONSTITUENCY FROM LASALLE TO
LASALLE-ÉMARD-CÔTE SAINT-PAUL**

Mr. John Campbell (LaSalle) moved that Bill C-228, an act respecting the Electoral Boundaries Readjustment Act, be read the second time and referred to the committee of the whole House.

He said: Mr. Speaker, the reason for this bill to change the name of my riding from LaSalle to LaSalle-Emard-Côte Saint-Paul is basically that Emard-Côte Saint-Paul forms an integral part of my constituency. Its present name is not indicative of the vastness of the other two municipalities that form part of the riding, and to recognize the citizens there I would ask that the name be changed.

Motion agreed to, bill read the second time and the House went into committee thereon, Mr. Boulanger in the Chair.

On Clause 1—*LaSalle-Émard-Côte Saint-Paul*.

Mr. Fairweather: Mr. Chairman, I am not going to rain on anyone's parade; I would not think of it, but I do want to point out that there is a better way of accomplishing a certain purpose. I want to compliment the Prince Edward Island Redistribution Commission on the fact that, rather than picking names of prominent municipalities within the electoral district, it picked prominent geographical locations such as headlands, mountains, points or rivers and so on. I do not object to the hon. member's bill, as we have a tradition here of accepting these proposals. However, for the sake of the Chair, the printing bureau and anybody else involved, I hope it will be possible as redistributions are carried out again that, rather than having a string of three or four names in the name of the constituency, the commissions will not try to salve every municipality within the area but will settle upon prominent geographic features.

Prince Edward Island was able to do this with names such as Malpeque, Hillsborough and so on. What is the other one?

An hon. Member: Cardigan.

Mr. Fairweather: Yes, Cardigan indeed. I think this is a better way to proceed. This is only a caveat, and I do not want to interfere with the quite proper proposal of the hon. member. I hope, however, we do not extend this practise very much further as it presents a difficulty for everyone having to do with parliament.

Clause 1 agreed to.

Title agreed to.

Bill reported.

Mr. Deputy Speaker: When shall the said bill be read a third time?

Mr. Knowles (Winnipeg North Centre): By leave now.

Mr. Campbell moved that the bill be read the third time and do pass.

Motion agreed to and bill read the third time and passed.
