REQUEST FOR AID TO FOREST INDUSTRY IN QUEBEC—MOTION UNDER S.O. 43

**Mr. Armand Caouette (Villeneuve):** Mr. Speaker, pursuant to the provisions of Standing Order 43, I wish to move a motion on a matter of urgent and pressing necessity.

In view of the deplorable situation presently prevailing in the forest industry in Quebec and in view of the very high unemployment rate which affects the Canadian society and economy, I move, seconded by the hon. member for Champlain (Mr. Matte):

That the House consider the opportunity to provide immediate assistance to the forest industry in order to revive the economy of our area.

SUGGESTED NAMING OF DONORS OF SWIMMING POOL TO ASCERTAIN POSSIBLE CONFLICT OF INTEREST—MOTION UNDER S.O. 43

**Mr. Tom Cossitt (Leeds):** Mr. Speaker, I rise under the provisions of Standing Order 43 to move a motion that is self-explanatory. I move, seconded by the hon. member for Winnipeg South Centre (Mr. McKenzie):

That in view of the Washington announcement that a swimming pool will be constructed in the White House and that the President of the United States is prohibiting donations from business corporations and labour unions, that no donation over \$1,000 will be accepted, that the total cost of the pool will be approximately \$52,400, the House calls upon the Prime Minister to immediately follow this example of full disclosure by announcing forthwith all details surrounding construction of a \$200,000 swimming pool at his official residence at 24 Sussex Drive with the names of all donors and the amounts donated being

made public immediately in order to clearly establish whether or not improprieties or conflict of interest factors exist.
