What amount was spent to date by NRC on materials used for the Teleoperator System and approximately what amount was imported from outside of Canada?

Mr. Pierre Bussièrès (Parliamentary Secretary to Minister of State for Science and Technology): In so far as the National Research Council is concerned, the reply is as follows: It is estimated for the project as a whole that 70 per cent of the expenditures are for labour and 30 per cent for materials so that approximately \$21,521,000 has been expended on materials. It is also estimated that Canadian content of this project is 90.7 per cent so that approximately \$2,000,000 has been expended to date on materials from outside of Canada.

*LAW REFORM COMMISSION—ADMINISTRATIVE AND FOREIGN SERVICE

Question No. 235—**Mr. Woolliams:**

With reference to the projected 1978-79 Estimates expenditure of the Law Reform Commission of Canada for Administrative and Foreign Service personnel (a) what services and functions do the Foreign Service personnel perform (b) where do the personnel in this category work (c) what are the names of the persons now occupying these positions?

Mr. Claude-André Lachance (Parliamentary Secretary to Minister of Justice): The Law Reform Commission of Canada employs three public servants of the administrative and foreign service category, but none of these are of the foreign service classification. The functions, work location and names of the three employees of the administrative service classification are as follows:

(a) Services and functions:

(i) The secretary of the commission is responsible to the chairman for policy and planning governing the operations of the commission's headquarters in Ottawa and its regional office in Montreal.

(ii) The office manager of the Montreal regional office is responsible for the operations of the commission's Montreal regional office.

(iii) The office manager of the headquarters of the commission in Ottawa is responsible for the efficient functioning of office support services.
