#### MILK IN NEW FORM

## Question No. 772-Mr. Cossitt:

To the knowledge of the government, when will the new form of milk which does not require refrigeration and which will keep in sealed containers for at least six months be available to the general public and will the Department of Agriculture do anything to help promote the sale of such milk in order to assist the dairy industry?

Hon. E. F. Whelan (Minister of Agriculture): Currently, the ultra high temperature (UHT) milk is produced in Quebec and Alberta and distributed in Newfoundland and British Columbia.

In the near future, it will be produced and distributed in Ontario and, later this year, production will commence in British Columbia.

Agriculture Canada has helped to promote its production by providing technical expertise in the evaluation of applications for DREE grants for production facilities and by supplying the trade and public with information relating to the new product.
