DRILLING OPERATIONS—SERVICE SECTOR DIFFICULTIES

Hon. Don Mazankowski (Vegreville): Madam Speaker, I would like to direct a question to the Minister of Energy, Mines and Resources. The Minister will be aware that this week there have been several representatives of the energy supply and service sector in Ottawa making representations to Members of Parliament, and indeed to Government, on the very serious difficulties that are being faced by that sector as a result of the slowdown in drilling activity in these sedimentary basin. Less than 30 per cent of the drilling fleet is working. That has a direct impact upon the service and supply sector. What words of encouragement and hope has the Minister given this very important sector, or is he going to allow this multi-billion industry to collapse like a punctured balloon?

Hon. Jean Chrétien (Minister of Energy, Mines and Resources): Madam Speaker, the message of hope that I can give to them is that for 1983 it is forecast that the cash flow in the industry will increase by about 8 per cent or 9 per cent while the same industry in the United States will see a negative cash flow in 1983. The fact that we have been able to increase the price of a barrel of oil by \$4 as of January 1 substantially improved the position of that industry in relation to the situation south of the border. As you know, some of the people who were very keen to go to the United States some years ago, have come back to Canada. For instance, Total Petroleum have indicated that they are now very happy that they were not able to sell their Canadian assets two years ago. They kept those assets, and the Canadian sector of the company is the only one in which there was a profit made this year.
