### NATIONAL DEFENCE

#### PRESENTATION OF WHITE PAPER

Mr. Derek Blackburn (Brant): Mr. Speaker, my question is for the Minister of National Defence. There has been a lot of confusion about whether or not we are going to receive a White Paper on defence. Can we expect a White Paper on defence some time in the late winter or spring?

Hon. Erik Nielsen (Deputy Prime Minister and Minister of National Defence): Mr. Speaker, I can give that very helpful suggestion every consideration. In the meantime, we have not been waiting for a year; we have been waiting closer to 14 years.

## APPOINTMENT OF CENSUS COMMISSIONERS

Mr. John Nunziata (York South-Weston): Mr. Speaker, my question is directed to the Minister of Supply and Services. Earlier he said that only qualified and competent census commissioners were hired. In view of the fact that incompetent and unqualified Tory hacks and flacks were hired, will the Minister immediately instruct the dismissal of all those who failed to achieve 60 per cent on the test in order to qualify to be commissioners?

Hon. Stewart McInnes (Minister of Supply and Services): Mr. Speaker, there are two tests. One is written and one is oral, and the examiner takes both tests into account. If I ordered the dismissal of all of those who failed one of the tests, a great number of the nominees from over there would fail.

Hon. Don Mazankowski (Minister of Transport): Mr. Speaker, I think the Hon. Member is aware that, under the provisions of the ruling handed down, there is a period of time during which a decision can be appealed, and it would be inappropriate for me to comment until that time has expired.

Mr. Iain Angus (Thunder Bay-Atikokan): Mr. Speaker, my supplementary question is directed to the Minister of Transport. Does the Minister not agree that any increase in any costs related to the marine industry on the Seaway will be detrimental to its survival?

Hon. Don Mazankowski (Minister of Transport): Mr. Speaker, my response would be the same. I would be prepared to express an opinion, perhaps in another context, but I think in light of the responsibility that I have, I would want to refrain from making any suggestions at this time.
