again to \$14 billion. By 1995 it will stand at \$10 billion and at that time we will regain control over our economy.

Madam Speaker, there being no ready-made solution to the ever growing national debt problem, the steps taken in this budget are therefore essential if we are to bring lasting economic prosperity to this country.

The priority of our government since 1984 has been to get a handle on the deficit and the national debt while restoring better control over our finances. Such was the mandate given to us by all Canadians. When we came into office, forecast program expenditures were \$16 billion more than revenues. Now, the government's expenditures are \$9 billion less than its revenues. This turnaround of more than \$25 billion makes all the difference and proves that we know how to manage our finances.

Significant economical progress has been made because we have controlled program and federal service growth. Budgetary initiatives, combined with better management and the implementation of the goods and services tax make up the government's economic strategy to restore our country's financial health and improve our economic performance on the international scene.

This budget takes into account the economic situation in Quebec. I want assure Quebecers to know that the extra help they receive through equalization payments will remain untouched. Neither will it be affected by the 5 per cent limit imposed on federal transfers under the Canada Assistance Plan. In fact, major transfers to Quebec should increase overall by some 3,2 per cent in 1990–91, and 3,4 per cent in 1991–92.

In sum, Madam Speaker, Canadians have adjusted well to the changes introduced by this government. The number of jobs created and our numerous achievements prove that our policies are working.

Our mandate is to restore Canada's financial balance, and because of that we are committed to reducing the waste that was a major contributor to the debt. We will keep on making the changes that are needed as long as this country's economy has not stabilized.

In conclusion, Madam Speaker, I am proud to be part of a government that does not balk at taking drastic measures where needed. This government is not concerned with its popularity when the welfare and future of Canadians are involved. We therefore will keep on acting in the best interests of all.

If the hon. member has any other highlights that she may have overlooked with respect to how this budget affected Quebec, I think it would be in Canada's good interest to know.
